Parents: please carefully go over and discuss this agreement with your child

Purpose:

Irwin Academic Center is committed to providing our students with enriching learning experiences across all subject areas. We embrace instructional technology and the unique opportunities it provides us to enhance our classroom instruction. Infusing technology into our instruction allows our students to communicate and collaborate, think critically, and create a variety of different products to showcase their learning. We are excited about the educational possibilities that iPads bring to Irwin!.

Plan:

Beginning on September 17, 2018,, students who return this agreement filled out correctly and completely, will have use of a CMS iPad in the classroom **at their teacher's discretion**. Students in grades K & 1 will have iPad carts housed at their grade level so that they may utilize them, as needed. iPads are to remain at Irwin Academic and are not to be taken home. Students will be able to access their CMS Google account from the iPad. All iPads are automatically connected to the CMS server and are pre-loaded with grade level appropriate apps.

Student and Parent/Guardian Agreement:

Students **MUST** adhere to the Student Code of Conduct, all CMS Board Policies, CMS & Irwin Academic's Acceptable Use Policy, Internet Safety Policy, and Irwin Academic iPad Agreement. Violation of any of these policies will result in immediate consequences as deemed appropriate for the violation by the Principal (Dr. Ashford) and the Technology Administrator (Mrs. Spraggins). Student takes full responsibility for their use of iPads **at all times**..

iPad use is a privilege, not a requirement, and can be revoked at any time due to teacher, principal, technology administrator's discretion.

PLEASE READ CAREFULLY. BOTH STUDENT & PARENT MUST INITIAL EVERY STATEMENT:

_____ iPads **MUST** be in "silent mode" while on school campus unless otherwise directed by my teacher.

_____ iPads may **NOT** be used for non-instructional purposes while on campus (*it is not to be used to play games, for "chat" or "social" purposes, or to listen to music*) Acceptable games will be determined by teacher and technology administrator.

_____ iPads may **NOT** be used to record, transmit, or post photographic images or video of people on campus unless assigned by the teacher.

_____ iPads should **ONLY** be used to access files or internet sites which are relevant to classroom curriculum.

_____ I will comply with my teacher's request to turn off/return my device when asked.

_____ iPads are for **CLASSROOM ACADEMIC USE ONLY**.

_____ I will **NOT** have an iPad out at **LUNCH, RECESS**, or during **ANY Other** part of the day when it is not requested by a teacher to have an iPad with me.

_____ I will not manipulate or adjust the Server installed on the iPad.

_____ I acknowledge that my teacher or administrator may examine the iPad **AT ANY TIME** for the purpose of enforcing the terms of this agreement, investigating discipline issues, or any other school related purpose.

_____ I will not use personal or private accounts while on the iPad.

_____ I will not **manipulate/change/adjust** the iPad in any way (apps, backgrounds, iPad identification, passwords, etc).

_____ If anything happens to the iPad (damage, inappropriate websites, etc.) I will let my teacher and/or Mrs. Spraggins know immediately

_____ iPads are not to be taken home for any reason.

_____ I acknowledge that I remain subject to all other school rules and expectations while using the iPad at school.

Again, it is very important to remember that the use of iPads to support educational experience is **NOT A NECESSITY BUT A PRIVILEGE**. With respect to the rules, this privilege will benefit the learning environment as a whole. When rules are abused, privileges will be taken away by the classroom teacher, technology or school administration.

Security & Damages

Any damages or problems with the iPad should be brought to the attention of the teacher or technology administrator immediately.

Consequences:

Violation of the aforementioned guidelines and policies will result in any of the following consequences: Infractions that violate the CMS and Irwin Academic Agreements/Policies will be handled at the discretion of the teacher, principal, technology administrator, and/or CMS technology department.

Consequences include **but are not limited to:**

- >Verbal warning
- >Parent meeting
- >Student will be banned from school technology and/or iPad for amount of time determined by the severity of infraction ex-1 day to remainder of the year)
- >Student school account will be suspended (amount of time to be determined by severity of infraction)

I understand and will abide by all of the acceptable use guidelines in this agreement. I understand that violation of these guidelines may result in losing my privilege to use school iPads and could lead to other disciplinary action.
